WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0875 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. 2021-0635 re; Procurement of Engine Oil, ATF, Brake Fluid, Gear Oil & Coolant, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of ₱ 181,700.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JAN SURPLUS CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
