



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE-BOHOL INFORMATION AND COMMUNICATION TECHNOLOGY OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0288; re; Procurement of VPS Subscription, by the Governor's Office-Bohol Information and Communication Technology Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 240,000.00;
