WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0450 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL VETERINARIAN, in undertaking Procurement Request under PR No. 2021-0557, re: Procurement of Supply & Installation of Stainless Built-up Storage, by the Office of the Provincial Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 92,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIQ offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- a). To declare ADS & PRINTS REPUBLIQ as the supplier with the **Lowest Calculated and Responsive Price Quotation** for the Delivery of **Goods/Services** under Negotiated Canvass No. 2021-0450 (2<sup>ND</sup> Failure);
- b). To recommend award to ADS & PRINTS REPUBLIQ or delivery of goods/services under Negotiated Canvass No. 2021-0450 (2nd Failure) in the amount of P 92,350.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


