



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

**RESOLUTION NO. 21-122B

WHEREAS, THE OFFICE OF THE VICE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0749; re: Procurement of Various Spare Parts for Mitsubishi Strada with Plate No. SHS - 351, by the Office of the Vice Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 149,480.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200M AUTO REPAIR SHOP AND PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- b.) To recommend award to 200M AUTO REPAIR SHOP AND PARTS for the delivery of goods/services under Negotiated Canvass No. 2021-0516 in the amount of P 149,100.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
