BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY (BOHOL ISOLATION CENTER) of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 079 re: Procurement of various MEDIAL SUPPLIES with an ABC of P 129,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BYRO PHARMA offered the Single price quotation as reflected in the Abstract of Bid Quotations,

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
