

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, THE OFFICE OF THE GOVERNOR - SPECIAL PROJECT SECTION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0754; re; Procurement of Sound & Lights, LED Wall Rental, Live Streaming for the Annual Events/Celebrations, Projects & Program of the PGBh, by the Office of the Governor - Special Project Section, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 350,000.00;

NOW, THEREFORE, We, the Members of the Quotations and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


