BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 2021 - 1328

WHEREAS, the GO-CENTER FOR CULTURE & ARTS DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0812; re; Procurement of Vehicle Rental, by the Center for Culture & Arts Development, New Capitol Compound, Tagbilaran City. with an ABC of P 430,000.00.
