

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 199 re: Procurement of LABORATORY REAGENTS with an ABC of P 619,532.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY offered the Single price quotation as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY for the delivery of goods under Negotiated Canvass No. 2021 - 158 (Emergency Cases) in the amount of P 619,160.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


