BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 220 re: Procurement of MEDICINES with an ABC of P 1,416,900.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the Single price quotation as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of DEXTEL TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, DEXTEL TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


