WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 333 re: Procurement of SULFUR 10% OINTMENT with an ABC of P 300,000.00;



- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




