BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 2021-425 Series of 2021

WHEREAS the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 333 re: Procurement of SULFUR 10% OINTMENT with an ABC of P 300,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BYRO PHARMA</u> offered the Single price quotation as reflected in the Abstract of Bid Quotations,
