WHEREAS, the PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL, PRES. GARCIA, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 344 re: Procurement of COVID – 19 Ag. RAPID ANTIGEN TEST - NASOPHARYNGEAL with an ABC of P 95,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




