

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Responsive Quotation and Recommending Approval

WHEREAS, the **CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2021 - 383** re: **Procurement of MEDICINES** with an ABC of **P1,517,044.20**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:
