WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. 2021 - 419 re: Procurement of COVID-19 RAPID ANTIGEN TEST DEVICE & KIT with an ABC of P 2,400,000.00;
