WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0231 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0302 re: Procurement of 55 inches Television to Support Promotion of Information & Marketing need of Bohol Island Aspiring Geopark, by the Bohol Environment Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol with an ABC of ₱ 45,000.00;
