LCRQ and Recommending Award

RESOLUTION NO. 21-1349 Series of 2021

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-465-series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the CANDIJAY COMMUNITY HOSPITAL in undertaking Procurement Request under PR No. INF-2021-0035 re: Procurement of Labor, Materials & Equipment for the Painting, Tileworks & Installation of Airconditioning of Cemonc Building at Candijay Community Hospital. with an ABC of P 969,024.84;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CLAIRE</u> <u>CONSTRUCTION & SUPPLY</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, CLAIRE CONSTRUCTION & SUPPLY has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare <u>CLAIRE CONSTRUCTION & SUPPLY</u> as the supplier with the <u>Lowest and Responsive Price Proposal</u> for the Delivery of <u>Goods/Services</u> under Negotiated Canvass No. <u>NC-2021-0012 (2<sup>pd</sup> Failure)</u>;
- b). To recommend award to <u>CLAIRE CONSTRUCTION & SUPPLY</u> for delivery of goods/services under Negotiated Canvass No. <u>NC-2021-0012/(2<sup>nd</sup> Failure)</u> in the amount of <u>P 968,168.00</u>;
- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
