WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0799 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ACCOUNTING OFFICE in undertaking Procurement Request under PR No. 2021-0596 re: Procurement of I.T. Equipment, by the Provincial Accounting Office, Bohol Provincial Capitol Building, Cooon District, Tagbilaran City, Bohol, with an ABC of P 384,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SANDUGO PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
