



BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding,
Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0900 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2021-0611 re: Procurement of Various Office Supplies, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 283,339.40;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed SANDUGO PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, SANDUGO PRESS MARKETING AND SUPPLIES has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare SANDUGO PRESS MARKETING AND SUPPLIES as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. 2021-0470 (2nd Failure);
- b). To recommend award to SANDUGO PRESS MARKETING AND SUPPLIES in the amount of P 282,814.00 for delivery of goods/services under Negotiated Canvass No. 2021-0470 (2nd Failure);
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
