



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated Responsive Quotation and Recommending Approval

WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2021 - 191 re: **PROCUREMENT OF VARIOUS DRUGS AND MEDICINES** with an ABC of **P 174,020.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of DEXTEL TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid DEXTEL TRADING has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare DEXTEL TRADING as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 169,450.00** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2021 - 154;
- b.) To recommend award to DEXTEL TRADING in the amount of **ONE HUNDRED SIXTY NINE THOUSAND FOUR HUNDRED FIFTY PESOS ONLY (P 169,450.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 154;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
