WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-1254 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-179 re: BULK PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 4TH QUARTER OF CY 2021 – C. TRAININGS/ SEMINARS/ WORKSHOPS AND CONSULTATIVE MEETING AND OTHER CAPACITY – BUILDING RELATED ACTIVITIES – WITHIN TAGBILARAN with an ABC of P 5, 079, 450.00;
