



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

**WHEREAS**, the **CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2021 - 405** re: **PROCUREMENT OF VARIOUS MEDICAL SUPPLIES ABC of P 298,275.00;**


**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DEXTEL TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals.

**WHEREAS**, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **DEXTEL TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **DEXTEL TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **DEXTEL TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 296,533.00** for the **DELIVERY OF GOODS/SERVICES** under **Negotiated Canvass No. - PHO - 2021 - 321;**
- b.) To recommend award to **DEXTEL TRADING** in the amount of **TWO HUNDRED NINETY SIX THOUSAND FIVE HUNDRED THIRTY THREE PESOS ONLY (P 296,533.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2021 - 321;**
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




