



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **CENTER FOR DRUG EDUCATION AND COUNSELLING (CEDEC)** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2021 - 406 re: PROCUREMENT OF DRUG TESTING KIT with an ABC of P499,950.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DEXTEL TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **DEXTEL TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **DEXTEL TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **DEXTEL TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 484,800.00** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2021 - 322;
- b.) To recommend award to **DEXTEL TRADING** in the amount of **FOUR HUNDRED EIGHTY FOUR THOUSAND EIGHT HUNDRED PESOS ONLY (P 484,800.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 322;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
