WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the Garcia Memorial Provincial Hospital, Talibon, Bohol in undertaking Procurement Request under PR No. – PHO – 2021 – 037 re: PROCUREMENT OF MEDICAL BEDSIDE TABLE, EMERGENCY CART, FILING RACKS, IV STAND, MONOBLOCK CHAIR, MAYO STAND AND MEDICINE TROLLEY with an ABC of P 629,632.50;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that IRASETH PHARMA INC. offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- c. To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




