WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0474-A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICER undertaking Procurement Request under PR No. 2021-0402 re: Procurement of Utility Truck for Rice Delivery (Dry-Back Operation Use) by the Provincial Economic Enterprise Management Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 2,250,000.00;
