WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 01-0902 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by THE PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0530 re; Procurement of Materials for Construction of Slope Protection for Various Bridge under Project Management Division III (Bohol District III), by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of ₱ 786,015.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that A & D CONSTRUCTION AND SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- a). To declare A & D CONSTRUCTION AND SUPPLY as the supplier with the Lowest Calculated and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. 2021-0440 (2ND Failure);
- b). To recommend award to A & D CONSTRUCTION AND SUPPLY or delivery of goods/services under Negotiated Canvass No. 2021-0440 (2nd Failure) in the amount of ₱ 782,164.25;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


