WHEREAS, the PROVINCIAL ASSESSOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-202 re: PROCUREMENT OF MEALS, SNACKS AND HOTEL ACCOMMODATION FOR 3 DAYS LIVE-IN SEMINAR OF 100 PERSONNEL OF THE 47 LGUs FOR THE CONDUCT OF A SEMINAR FOR SMV DEVELOPMENT TRAINING (RPTIS, QRRP & GIS) with an ABC of ₱ 200,000.00;

- a). To declare THE METROCENTRE HOTEL as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATIONS for the CATERING AND ACCOMMODATION SERVICES under Negotiated Canvass No. 2021-175;
- b). To recommend award to THE METROCENTRE HOTEL for the Catering Services of the aforementioned request in the amount of ₱ 200,000.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




