

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0894 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0619 re: Procurement of Fuel for the Equipment assigned for the widening, reshaping, and regraveling of Barangay Dataq Sur, Balilihan, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 213,180.00;

- b). To recommend award to PETROBEST (PETRON) SERVICENTER or delivery of goods/services under Negotiated Canvass No. 2021-0465 (2nd Failure) in the amount of ₱ 211,403.50;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
