WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u>, <u>NEW CAPITOL BUILDING</u>, <u>COGON DISTRICT</u>, <u>TAGBILARAN CITY</u>, of the <u>PROVINCIAL</u> GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 151</u> re: <u>PROCUREMENT OF FDA REGISTERED HIV RAPID TESTING KITS ABC of P 420,000.00</u>;
