

BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-157 re: PROVISION OF CATERING SERVICES DURING THE 121st CIVIL SERVICE ANNIVERSARY WITH THE THEME : "TRANSFORMING PUBLIC SERVICE IN THE NEXT DECADE: HONING AGILE & FUTURE-READY SERVANT-HEROES" with an ABC of ₱ 300,000.00;

- b). To recommend award to REYNA'S THE HAVEN & GARDENS FOOD CATERING SERVICES, INC. for the Catering Services & Accommodation of the aforementioned request in the amount of ₱ 295,500.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


