WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0911-A series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL ENVIRONMENT MANAGEMENT OFFICE, in undertaking Procurement Request under PR No. 2021-0210 re: Procurement of Laptop for use at the Water Resource Management Section. Assigned by Bohol Environment Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of ₱ 50,000.00.
