WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0878, series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL VETERINARIAN in undertaking Procurement Request under PR No. 2021-0627 re: Procurement of Engine Oil, Oil Filter, Fuel Filter with Repair, by the Office of the Provincial Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 212,045.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, 200 M AUTO REPAIR SHOP & PARTS has been found to be ELIGIBLE and its quotation, RESPONSIVE;
