WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0828A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT in undertaking Procurement Request under PR No. INF-2021-0069 re: Furnishing of Labor, Materials and Equipment for the Concrete Floor Slab for Covered Court at Bohol Youth Home at Cortes, Bohol, by the Office of the Provincial Social Welfare and Development, Tamblot St., Tagbilaran City. with an ABC of ₱ 691,647.15;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


