WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **Pres. Carlos P. Garcia Municipal Hospital, Pres. Garcia, Bohol** in undertaking Procurement Request under **PR No. - PHO - 2021 - 046** re: **PROCUREMENT OF FLOOR POLISHER, JANITOR CART, GARBAGE BIN, ELECTRIC/AUTOMATIC HAND DRYER, AIR CONDITIONING UNIT, LED SMART TELEVISION & MEDICAL OXYGEN CART WITH WHEELS** with an ABC of **P 600,000.00**;



WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **BOHOL QUALITY CORPORATION** has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- To recommend award **BOHOL QUALITY CORPORATION** in the amount of **FIVE HUNDRED NINE THOUSAND EIGHT HUNDRED EIGHTY PESOS AND 25/100 (P 509,880.25)**; for the Delivery of Goods under **Negotiated Canvass No. - PHO - 2021 - 061 (2<sup>nd</sup> failure of bidding)**;
- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
