

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 332 re: PROCUREMENT OF TUBELESS TIRES with an ABC of P 202,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES AND SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of TAGBILARAN CITY TYRE SALES AND SERVICE CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid TAGBILARAN CITY TYRE SALES AND SERVICE CENTER, has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b) To recommend award to TAGBILARAN CITY TYRE SALES AND SERVICE CENTER in the amount of TWO HUNDRED TWO THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (P 202,460.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 259;
- c) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
