WHEREAS, THE PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0802; re; Procurement of Electrical Materials for the PGBh Activities Lighting, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City. with an ABC of P 467,875.00;



- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods/services under Negotiated Canvass No. 2021-0537 in the amount of P 466,000.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
