WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 – 345 re: PROCUREMENT OF COVID – 19 Ag Rapid Test Device (Nasopharyngeal) with an ABC of P 520,000.00;


