



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL PLANNING AND DEVELOPMENT OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0830; re; Procurement of Vehicle Rental During Project Monitoring, Evaluation of LRNDP, PaDTEC & Geo-Resistivity Survey for Possible Water Source (BIWRMP), Data Gathering/Validation & Delivery of Communication to Different LGUs, by the Provincial Planning and Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC P 69,500.00.


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
