

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 21-13-58 Series of 2021

WHEREAS, the PROVINCIAL PLANNING AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0830; re; Procurement of Vehicle Rental During Project Monitoring, Evaluation of LRNDP, PaDTEC & Geo-Resistivity Survey for Possible Water Source (BIWRMP), Data Gathering/Validation & Delivery of Communication to Different LGUs, by the Provincial Planning and Development Office; Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC P 69,500.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL TOURIST MULTI-PURPOSE</u> <u>COOPERATIVE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> as the bidder with the <u>LOWEST CALCULATED</u> AND RESPONSIVE BID for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2021-0565</u>;
- b.) To recommend award to <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> for the delivery of goods/services under Negotiated Canvass No. <u>2021-0565</u> in the amount of P 69,500.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
