

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2021-0886** re: Procurement of Rice (Well Milled) 50kls/sack, Tamblot Street, Cogon District, Tagbilaran City, Bohol with an ABC of P 4,700,000.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MULTI-PURPOSE COOPERATIVE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,



- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


