

Procurement thru Negotiated Method Resulting from the Second Failure of Bidding,
Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0471-A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2021-0429 re; Procurement of I.T Equipment & Filing Cabinet, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of ₱ 626,400.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
