WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL PLANNING & DEVELOPMENT OFFICE in undertaking Procurement Request under PR No. 2021-0668 re; Procurement of LCD Projector & Computer System, by the Provincial Planning & Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of \$\frac{1}{2}\$ 367,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
