

BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2-08 Series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE in undertaking Procurement Request under PR No. INF-2021-0067 re: Completion of Tarsier Office Basement at Dao District, Tagbilaran City, by the Provincial Disaster Risk Reduction and Management, Dao District, Tagbilaran City, with an ABC of P 961,355.44;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>C.</u>

- c) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
