WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0796 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL VETERINARIAN in undertaking Procurement Request under PR No. 2021-0608 re; Procurement of Diesel Fuel, by the Office of the Provincial Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 200,000.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


