WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0179-1 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **GO - PROVINCIAL INFORMATION & MEDIA RELATIONS** in undertaking Procurement Request under PR No. 2021-0398 re: Procurement of Various Equipment/Devices for Broadcasting, Live Streaming & Field Documentation of All PGBh Programs, by the GO - Provincial Information & Media Relations, Bohol Provincial Capitol Building, Cocon District, Tagbilaran City, Bohol, with an ABC of ₱ 74,801.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




