WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021 - 309 re: Procurement of OXYGEN TANK REGULATOR, NASAL CANNULA, AND PULSE OXIMETER with an ABC of P 351,600.00;






