WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the COMMISSION ON AUDIT in undertaking Procurement Request under PR No. 2021-0374 re: Procurement of IT Equipment, by the Commission on Audit, Dao District, Tagbilaran City, Bohol, with an ABC of ₱ 94,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


