
WHEREAS, the above Procurement Request was presented to the BIDS AND AWARDS COMMITTEE for deliberation and proper action;

- b) To declare COPYLANDIA OFFICE SYSTEMS CORP. as the sole distributor of said products in the amount of P 258,000.00 for item nos. 1 & 3-6 while item no. 2 is for cancellation under Direct Contracting Canvass No. 2021-0055; thus, recommendation for award is hereby conferred to;
- c) To recommend approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


