WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0242 Pet Procurement Fermented Pure Chicken Manure (With Analysis Of Nitrogen (3.41%), Phosphorus (1.14%), Potassium (2.48%), Organic Matter (51%) Packaging: Laminated Polypropylene, 50 Kilos/Bag For 1st Cropping, Office Of The Provincial Agriculturist, Tagbilaran City with an ABC of P1,044,400.00;
