BAC Resolution Recommending the Use of Negotiated Procurement through Small Value Declared Laboration and Recommending Approval

## RESOLUTION NO. 21-1154 Series of 2021

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0479; re; Procurement of Gasoline, by the Office of the Provincial Agriculturist, Bohol Provincial Capital Building, Cogon District, Tagbilaran City, Bohol. with an ABC of P 120,830.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL JL DISTRIBUTION SYSTEM INC.</u>
