



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0757; re; Procurement of Diesel for Service Vehicle for the Monitoring/Evaluation, Transport Agricultural Inputs of the Agri-Fishery Programs, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of P 162,999.00






